## Subject: Extension of deadline and more inclusive public consultation on the Draft Broadcasting Services (Regulation) Bill, 2023

We, the undersigned civil society organisations and individuals, write to you to share key concerns and demands regarding the ongoing consultation process on the Draft Broadcasting Services Bill, 2023.

A text of the Bill was placed in public domain on 10th November on the Ministry's website and comments have been invited till 09th December 2023. The text of the Bill is accompanied by an explanation. Both the text of the Bill and the explanation are in English. This bill has far reaching consequences for all citizens and their right to access information and news. It completely overhauls the media regulatory framework. It brings OTT platforms under its ambit. Any reform of the media regulatory framework must further public interest and be grounded in the principles of the constitution to further freedom of speech and expression.

At this stage we would like to draw your attention to the Pre-Legislative Consultation Policy, 2014, which every Ministry is required to follow before legislative proposals are submitted to the

Cabinet for approval.<sup>1</sup> The specific mandates of the Policy are summarised below for your reference:

- Ministry shall proactively publish the proposed legislations both on the internet as also through other means;
- The text of the legislation should include brief justification for such legislation, essential elements of the proposed legislation, its broad financial implications;
- An estimated assessment of the impact of such legislation on environment, fundamental rights, lives and livelihoods of the concerned/affected people, etc. should also be made available along with the text of the proposed legislation;
- Such details may be kept in the public domain for a minimum period of thirty days;
- Where such legislation affects specific group of people, it may be documented and disclosed through print or electronic media or in such other manner, as may be considered necessary to give wider publicity to reach the affected people;
- The Ministry concerned might, in addition to placing the proposal in public domain, also hold consultations with all stakeholders.

We urge the Ministry to comply with all the above mandates of the PLCP to ensure an inclusive, multi-stakeholder and informed consultation on the legislative proposal. This is particularly crucial given the wide scope and far reaching ramifications of the Bill on free speech and access to information. Therefore, it is important that the Bill be provided wide publicity on different media platforms and along with it the Ministry must undertake open houses and in person public consultations on the Bill with affected stakeholders.

We also demand that the text of the Bill and the accompanying explanation be published and made available to the public in all Scheduled languages of the Constitution. We would like to point out that in the past also, the Government of India has facilitated consultations on policy proposals in multiple languages. For instance, the draft of the New Education Policy was translated in 22 languages and uploaded on the Ministry's website,<sup>2</sup> and similarly, the Draft Environment Impact Assessment Notification was also made available in multiple languages after a Delhi High Court order.<sup>3</sup> Therefore it is neither without precedent, nor practically impossible to make policy proposals available in public domain in multiple languages for the purpose of undertaking consultation. Furthermore, as the Ministry itself has claimed that it has used a simple language to draft the Bill, it would be even easier to translate the same.

Finally, given the length of the Bill and the complexity of the regulatory provisions proposed in the Bill, more time must be provided for affected stakeholders to study and analyse the Bill for its potential impact. The PLCP also mandates for a minimum of 30 day period, which must be

extended where needed to fulfill the desired objective of undertaking the consultation process, which is to enable multi-stakeholder deliberation on the Bill. **Therefore, we urge you to extend the deadline at least by another 30 days.** 

We have made the above demands to enable the Ministry to undertake meaningful, sustained and inclusive multi-stakeholder consultations, with opportunities for people across India to participate in the same.

We hope these demands will be taken in the right spirit and positively addressed.
